

Update from the Department of Early Learning August 2009

DIRECTOR'S NOTE

Some call it “the lazy days of August,” but there is no time for a break at DEL during these hot summer days! We are moving forward with our Early Learning Advisory Council and other key partners on drafting a statewide Early Learning Plan, which will serve as the roadmap for services to children and families in our state ages birth to 8 to make sure all kids are healthy, safe and ready for school. Also, Gov. Gregoire has requested that Superintendent of Public Instruction Randy Dorn and I deliver a proposal for the 2010 legislative session that ensures all children in Washington have the benefit of early childhood education. We are working at this with the help of the Early Learning Plan work groups.

So why does our state need an Early Learning Plan? Here are a couple sobering statistics:

- There are basic health needs that create great risk for children: In 2007, 4.6 percent of Washington children had no health insurance. In 2008, half of all births in our state were Medicaid-funded. The number of children living in families requiring food stamps has risen by 30 percent since 2007.
- Kindergarten teachers say fewer than half of kids enter school with the skills and knowledge they need to succeed.
- Between 1996 and 2006, median prices rose 30 percent but the cost of early care and education rose 60 percent.

We invest a lot in kids and families in our state— think of the possibilities if the various state agencies and organizations “talked” to each other more, and if children had services from birth that set them on the path to success. That's what we're aiming for with this plan.

Imagine a state where families have access to a menu of options: home visiting, health and nutrition services, affordable preschool classroom learning, help finding and paying for child care, parenting information and support, and all the other resources we know are essential to healthy child development. And providers and educators have the support they need to offer high-quality early learning settings and partner with other community services. Providers request extra development charts to teach, show parents

The response was enormous after DEL partnered with the Department of Health (DOH) CHILD Profile program to send “Watch & Help Me Grow!” development charts to all licensed child care providers in our state. Providers called and requested almost 1,500 additional copies in English and almost 500 copies in Spanish in just two weeks.



“We love them,” one child care center wrote. “Can you please send us more so that we can post them in each classroom and throughout our facility and talk to parents and staff about it?”

DEL has a limited supply left and will continue distributing extra copies until the quantity is depleted. Federal Child Care and Development Fund (CCDF) dollars for infant/toddler quality initiatives helped support this partnership.
