IMPORTANT TIMELINES:

- **Enrollment:** 100% of funded ECEAP slots by 30 calendar days after children’s classes begin.
- **Dental Screenings:** Children who have not had a dental exam within the last six months must receive one within 90 days of their first day in the classroom.
- **Medical Exams:** Children who have not had a medical exam within the last 12 months must receive one within 90 calendar days of their first day in the classroom.
- **Health Screenings:** Children who have not had a health screening within the last six months must be screened within 90 calendar days of their first day in the classroom (Standard D-7).
- **Developmental Screenings:** Screening for each child must occur within 90 calendar days of the child’s first day of class (Standard E-11).
- **DECA Assessments:** Complete for each child present during the first eight weeks of the school year, and for each child present during the last eight weeks of the school year.
